## Rules of Associate/ Affiliate Membership

**Criteria for Associate status:** (a.) Maintain ethical standards of professional conduct as set forth by the American Psychological Association in its Code of Ethics and as set forth in Maryland Code of Regulations; (b) Complete at least two (2) years of graduate work that is psychological in nature from an institution of higher education fully accredited by a regional accrediting body recognized by the Council on Postsecondary Accreditation or an institution that is publicly recognized as a member in good standing with the Association of Universities and Colleges of Canada, or (c) Possess a Masters degree that is psychological in nature from an institution of higher education fully accredited by a regional accrediting body recognized by the Council on Postsecondary Accreditation or an institution that is publicly recognized as a member in good standing with the Association of Universities and Colleges of Canada.

**Criteria for Affiliate status:** Affiliates of the Association shall be persons who can demonstrate a legitimate professional, educational or scientific interest in the field of psychology and who may not be eligible for any other level of membership. Affiliates shall not have voting rights or be eligible for elective office. Affiliates may serve as non-voting members of subcommittees but may not serve as chair. Examples of such persons may include, but are not limited to: (a.) Students of psychology at the undergraduate level. (b.) Secondary school teachers of psychology.
